- b. Treasurer Kathy O presented "2016 Budget Options." Much discussion in "Income" section re the Day in Al-Anon and the Holiday Party being fundraisers—or not. (Some remarks: Traditionally, both events have been fundraisers. This Holiday Party was unusual in that we paid no rent. If these are fundraisers, we can get money to send to WSO, which needs it. There has to be an admission fee to cover the events' costs. A raffle is a fun way to raise money. These events should be for recovery, fun and fellowship. We have plenty of money; they don't need to be for fundraising. A budget is just a target. Let's wait until the Literature Office matter is resolved before we decide what to do with the Prudent Reserve of \$3,000.) MOTION was made by Colleen and seconded by Linda L to finish this discussion and to vote on 2016 Budget at February 8 business meeting. Motion passed, with one vote against.
- c. Alateen Coordinator Lee B reported the Thursday Palo Alto meeting has closed due to lack of regular attendance. A new meeting is starting Wednesday, February 2, 4-5 pm, at the Ecumenical Hunger Program, 2411 Pulgas, East Palo Alto.
